- 1. The inter-se-seniority of successful candidates shall be determined in order of merit as assigned to them in OSSC merit list.
- 2. - 3. The name of the candidates shall be referred to the concerned collectors for verification of Character and Antecedents in pursuance to the Book Circular No. 11. On receipt of any adverse report, the appointment of the concerned candidate shall be cancelled.
- 4. The candidate may be directed to join in the O/o EIC (C) and O/o EIC (R.W.) within the period of seven days from the date of receipt of the appointment order.
- The E.I.Cs being the appointing authorities in respect of J.Es(C) are to issue appointment order in their favour immediately subject to obtaining medical fitness as per Rule 8(3) of the Odisha Diploma Engineers Service (Method of Recruitment and Conditions of Service) Rules, 2012 and obtaining Character and Antecedent Verification Certificates

from the respective Collectors in respect of the selected J.Es later, as statutory conditions of recruitment. After appointment, they will be provided with the requisite training by the respective E.I.Cs. as has been approved by Govt.

You are, hereby directed to issue appointment orders in respect of 294 J.Es(C) (from Sl No. 1 to 294) at your end and to place the services of 223 J.Es(C) (from Sl No. 295 to 517) with E.I.C, R.W for issue of appointment order at their level.
