No.FE-II(P) 51/2017 - 9009 /W ., Sri Hemanta Kumar Mohapatra, Assistant Engineer (Civil) of R&B Cadre under Administrative Control of Works Department is hereby promoted to the rank of Assistant Executive Engineer (Civil) on ad-hoc basis under regulation 3(2) (i) of O.P.S.C (Limitation of Function ) Regulation, 1989 in Pay Band-3 i.e. in the Scale of Pay of Rs 15,600/- - 39,100/- with Grade Pay of Rs 5,400/- as per OSRP Rules-2008 revised to Level-12 of the Pay Matrix under OSRP Rules, 2017 for a period not exceeding one year from the date of his joining in the promotional post or till recommendation of the OPSC is received and accepted by Government or till his retirement whichever is earlier. The pay of Sri Mohapatra will be notionally fixed in the above scale of pay of promotional post w.e.f the date of his immediate junior Er.
