Sub: - Providing facilities to the Graduate Architectures to encourage them to work as Contractors.

Government after careful consideration have been pleased to decide that the following facilities shall be extended to the Graduate Architectures at par with facilities provided to Graduate Engineers to encourage them to work as Contractors as cited below.

- (i) Each Graduate Architecture shall be entitled as "A" Class Contractor without making any deposit as required in Rule-7 infra on payment of registration fee at 50% (Fifty percent) of the normal rates.
- (ii) Each Graduate Architecture Holder having "A" Class Licence shall be allowed to participate in the tender without deposit of Earnest Money Deposit (E.M.D.) and I.S.D. at the time of signing the agreement and deduction of required percentage of Performance Security Deposit from the bills, the provisions prescribed in the P.W.D. Code Contractor's Registration Rules, 1967 as amended from time to time for "A" Class Contractor would be applicable to them all with such works provided their rates are competitive.
- (iii) Each Graduate Architecture Holder having "A" Class Licence shall be allowed for a maximum of three works in a financial year and the fact of a work with exemption of Earnest Money Deposit (E.M.D.) shall be entered in his Original Registration Certificate.
- (iv) Each Graduate Architecture having "A" class licence shall be awarded works up to Rs.2.00 lakh in a financial year at the current Schedule of Rates without calling for tenders.
- 1. This shall take effect from the date of issue of the Resolution and shall be available in Works Department web-site www.worksodisha.gov.in.
