

Sub:- Re-constitution of a permanent "Rate Board" for preparation of Schedule of Rates and supporting Analysis.



The Chairman "Rate Board" will also monitor preparation of Schedule of Rates for all works. It may be made clear to all the departments that Schedule of Rates is mandatory to adopt e-procurement system. All the Schedule of Rates finalized by the Committee shall be put forth before the Codes Revision Committee for ratification & finalization.
3. This supersedes Works Department O.M.No.7601/W dated 08.05.2007.


