No.WORKS-CON-CASE5-0217-2020 315 /W. WHEREAS, Berhampur Vigilance P.S. Case No. 26 dated 25.12.2020 U/s 13(2) r/w 13(1)(b)/12 of the P.C. (Amendment) Act, 2018 has been registered against Sri Udhab Padhi, Deputy Executive Engineer, Gunupur (R&B) Sub-Division under Rayagada (R&B) Division-II, Dist-Rayagada for possession of disproportionate assets to the tune of Rs. 1,47,61,555/- (Rupees One Crore Forty Seven Lakh Sixty One Thousand and Five Hundred Fifty Five) only to his known sources of income, which he failed to account for satisfactorily;

AND WHEREAS, the investigation of the Vigilance Case is in progress;

AND WHEREAS, Sri Padhi, D.E.E. has been arrested by the Vigilance authorities on 25.12.2020 and forwarded to the Court of the Special Judge, Vigilance, Berhampur on the same day from where he has been remanded to Judicial Custody till 06.01.2021.


AND WHEREAS, a Disciplinary Proceedings under rule-15 of the Odisha Civil Services (CC&A) Rules, 1962 is contemplated against Sri Padhi, D.E.E.;

NOW THEREFORE, Sri Udhab Padhi, Deputy Executive Engineer, Gunupur (R&B) Sub-Division under Rayagada (R&B) Division-II, Dist-Rayagada is deemed to have been placed under suspension in terms of Rule-12 of the Odisha Civil Services (CC&A) Rules, 1962 with effect from 25.12.2020 i.e. from the date of his detention in judicial custody and shall remain under suspension until further orders.

It is further ordered that during the period of suspension, the headquarters of Sri Padhi, D.E.E. shall be the Office of the Engineer-in-Chief (Civil), Odisha, Bhubaneswar and he shall not leave the headquarters without prior permission of the Engineer-in-Chief (Civil), Odisha, Bhubaneswar.

Sri Padhi, D.E.E. shall be entitled for payment of subsistence allowance in accordance with Rule-90 of the Odisha Service Code during the period of suspension.
