OFFICE ORDER

Bhubaneswar, Dated, the 13th January, 2021

No. WORKS-CON-CASE5-0010-2021- 411 /W., WHEREAS, Rourkela Vigilance P.S. Case No. 06 dated 16.12.2020 has been registered against Sri Narayan Pradhan, Assistant Engineer, Sundargarh GPH Section under GPH Division No. II, Sambalpur U/s 13(2) r/w 13(1)(b) /12 of Prevention of Corruption (Amendment) Act, 2018 for possession of disproportionate assets beyond his known sources of income and the same is under investigation.

AND WHEREAS, Sri Pradhan, Assistant Engineer was subsequently arrested by the vigilance authorities on 16.12.2020 & forwarded to the court on the same day from where he was remanded to judicial custody and spent a period exceeding forty eight hours under jail custody for involvement in a criminal case;

AND WHEREAS, a Disciplinary Proceedings under rule-15 is contemplated against Sri Pradhan, Assistant Engineer;

NOW THEREFORE, Sri Narayan Pradhan, Assistant Engineer, Sundargarh GPH Section under GPH Division No. II, Sambalpur is deemed to have been placed under suspension in terms of Rule-12 of the Odisha Civil Services (CC&A) Rules, 1962 with effect from 16.12.2020 i.e. the date of his detention in custody and shall remain under suspension until further orders.

It is further ordered that during the period of suspension, the headquarters of Sri Pradhan, Assistant Engineer shall be the Office of the Executive Engineer, GPH Division No. II, Sambalpur and he shall not leave the headquarters without prior permission of the concerned Executive Engineer.

Sri Pradhan, Assistant Engineer shall be entitled for payment of subsistence allowance in accordance with Rule-90 of the Odisha Service Code during the period of suspension.
