The above said engagements are subject to the following terms and conditions:

- The engagement will be made for a period of one year or till the vacancy is filled up on regular basis, whichever is earlier.
- The engagement can be terminated by Works Department at any point of time for dissatisfactory performance, on notice of one month. In case of any misconduct including misappropriation, negligence in duty of causing loss to the Govt., the services may be terminated without any prior notice.
- Besides the action under condition (ii) above, the OSD will also liable to be proceeded under the provisions of the Odisha Pension Rule for any act of misconduct during the course of discharging duties under re-employment.
- General instructions of Govt. regarding terms and conditions for engagement of officers as issued from time to time will be applicable and binding on the officers.
- In case the OSD desires to resign from the engagement, he may do so by giving a notice of one month in writing to the Commissioner-cum-Secretary, Works Department, under intimation to the Controlling Officer. After expiry of the notice period, the OSD may be relieved after handing over the full charges of the records and cash/Bank Accounts to the Relieving Officer as decided by Works Department or the Controlling Officer.

- vi. The engagement of the OSD will be subject to and will abide by the Conduct Rules applicable to the Govt. servants.
- vii. These terms and conditions are subject to Codal Provisions/ Memorandums/ Resolutions issued by Finance Department from time to time.
- viii. The OSDs are entrusted with the powers and responsibilities as indicated at Para 2.2.62, 2.2.64, 2.2.65 and 2.2.66 of OPWD Code Vol-I.
- ix. During the period of contractual engagement, the OSD may be accommodated with Govt. Quarters, as per GA (Rent) Department Letter No. 959 Dated. 04.02.2016
- x. The consolidated remuneration of the above mentioned OSDs will be fixed as per Finance Department guidelines issued vide their OM No. 7022 Dated. 17.03.2018.
- xi. Other terms and conditions of engagement will be guided by GA Department Resolution No. 23750 Dated. 27.08.2014.
